We held a community meeting on July 29, 2020 to solicit feedback and discussion regarding our reopening protocols and draft plans. The volunteer community members comprising the board of directors have been involved ongoing.

Due to the metrics released by the State of Oregon regarding return to in-person learning, we plan to provide comprehensive distance learning until it is safe to return to in-person schooling.

We have reviewed the Comprehensive Distance Learning Guidance, will comply with all requirements applicable to our independent learning environment, and do not require a review by ODE for any waivers or flexibility.

Describe the school's plan, including the anticipated timeline, for returning to Hybrid Learning or On-Site Learning consistent with the *Ready Schools, Safe Learners* guidance.

We will implement distance learning from September 14 until it is deemed safe for return to in-person learning. The distance learning plan is compliant with applicable elements of Oregon's Comprehensive Distance Learning Guidance. During distance learning, students will engage with the teacher and each other each day for group activities and interaction. In addition, each student in the cohort will receive one-on-one instruction daily. The goal is for teachers to have students engaged for the majority of the school day in a way that does not require substantial involvement of parents and caretakers. Students will engage in project-based, STEM-integrated, individualized learning just as they do in-person. Students will be provided instruction in language arts, social studies/humanities, math, science, art and foreign language. Students will be provided laptops, as needed, as well as school supplies and curriculum-related materials. Attendance will be taken daily.

Silverleaf may utilize limited in-person instruction for hands-on STEM learning, student assessment and evaluation of proficiency in hands-on skills. In the event that limited in-person instruction occurs, students will remain in their stable cohorts of no more than 8-10 students, with a stable instructor, will not be in school longer than two hours, and will comply with all other requirements regarding spacing, room capacity, sanitation and other protocols.

The person designated to enforce the physical distancing requirements of the plan is Cheri Leierer.</p> <p>We consulted with our Marion County Health Official Wendy Zieker as well as two retired physicians who are family members of students in regard to the Communicable Disease Management Plan and the COVID-19 protocols.</p> <p>Instructors will be trained prior to resuming in-person instruction during the weeks of August 24 – September 11 as well as prior to in-person instruction resuming once it is safe to do so. Trainings will be held virtually when possible.</p> <p>In the event of any confirmed cases among students or staff, the acting Administrator, Karen Litvin, will inform the LPHA as well as student families and staff.</p> <p>Protocols require systematic disinfection of all school areas daily with high-touch or shared use (i.e. bathrooms) areas being disinfected throughout the day.</p> <p>The protocols include expectations for screening students and staff, isolating ill or exposed persons, and for maintaining logs and information in accordance with guidance and state requirements. Logs will be maintained at the school for the duration of the school year and for at least two months after the last day of school.</p> <p>Silverleaf will follow all protocols outlined in <i>Planning for COVID 19 Scenarios in Schools</i> as well as LPHA guidance regarding action to be taken in the event of positive test case(s) within our school community.</p> <p>All students are part of a stable cohort of no more than 8 students, with no more than 15 students school-wide.</p> <p>We do not have any itinerant staff or staff that move between areas or buildings. The 35 square feet per person, including staff, will be maintained at all times.</p> <p>Cohorts are age-based. Our protocols outline strategies for compliance with all sanitation requirements, interaction limitations and information logs.</p> <p>Daily logs are kept with student name, drop off/pick up time and person dropping/picking up, and screening response. We maintain parent/guardian name and emergency contact information for all students. In the event of a substitute teacher for a cohort, names and phone numbers will be logged.</p> <p>Cohorts will not interact. There are visual cues within the school to help students maintain space during transitions or before/after school in areas where students store belongings. In the event a staff person interacts with more than one cohort, staff will wash hands between interactions.</p> <p>All surfaces are disinfected daily and high-touch surfaces are disinfected multiple times per day. We are able to significantly reduce shared surfaces by keeping students at individual desks, issuing individual school supplies and ensuring any shared supplies or equipment are checked out by a teacher and sanitized after each use.</p> <p>All students maintain equal access to instruction.</p>

We communicate with families and staff regularly via email to provide information about symptoms and efforts to prevent the spread of COVID-19.</p> <p>All students and staff will be screened daily in order to access the school. This will include taking temperature and self-attestation regarding symptoms and/or personal exposure to others outside of school. Logs will be kept regarding all persons entering the school. Only authorized personnel and students will be in the building, no guests or volunteers will be allowed and any others (such as parent/teacher meeting) will be by appointment only. Any persons entering by appointment will undergo the same screening and will not be permitted access if they do not pass the screening process.</p> <p>Anyone known to have been exposed, who does not pass screening, and/or shows any symptoms (that are not baseline such as allergies) will not be permitted entry to the school and we will follow protocols from <i>Planning for COVID 19 Scenarios in Schools</i>.</p> <p>All persons will sanitize their hands upon entry and exit of the school as well as prior to and after eating, prior to and after using the bathroom and frequently throughout the day. Visual reminders help students and staff with proper washing/sanitizing practices.</p> <p>Each family transports students to and from school, we do not have bus service.</p>
